

6TH GLOBAL RAIL FREIGHT CONFERENCE

FOR THE PAST 10 YEARS, THE INTERNATIONAL UNION OF RAILWAYS (UIC) HAS ORGANIZED A GLOBAL HIGH LEVEL EVENT ON FREIGHT AND LOGISTICS CALLED THE GLOBAL RAIL FREIGHT CONFERENCE (GRFC).

This year's edition of the GRFC is held under the Patronage of Regione Liguria and organised in partnership with the Ferrovie dello Stato Italiane S.p.A. (FS Italiane) at the Palazzo Ducale in Genoa (Italy) from 26 to 28 June 2018.

The GRFC is one of the leading and most prestigious events dedicated to rail freight and logistics at world level. After Rotterdam two years ago where the GRFC took place in parallel with the TEN-T Days of the European Commission, it is moving to Genoa, another historical landmark of modal integration and multimodal development.

The main conference topic, "Modal Integration at the service of Global Distribution" will be addressed by a host of prominent speakers representing the political and economic sectors, international institutions and all actors of the logistics chain, among them railways, ports and shipping lines, multi-modal operators, shippers.

The Ports of Genoa Guided Boat Tour

The Ports of Genoa ranks as the premier Italian port in terms of total traffic, handling almost 70 million tonnes of cargo yearly and offering over 150 liner services with over 500 ports worldwide. It is a multiservice port, catering to all key commodity sectors and guaranteeing a full range of vital complementary services. The port covers a total surface area of 7 million sqm, with 100 berths and depths up to 16 m alongside 27,000 m of quay line.

Delegates to the Global Rail Freight Conference 2018 have the opportunity to view the port's extensive and diverse facilities at first hand in this special guided boat tour. Departing from the Aquarium in the heart of Genoa's newly redeveloped old port, the tour will provide a breathtaking view of the city clustered around the bay, which has also developed into a thriving destination for cruise operators and today ranks amongst the leading Mediterranean cruise ports. This will be followed by a chance to view the full range of Genoa's dedicated terminals, equipped to handle all commodities: solid and liquid bulk, conventional cargo, perishable goods, steel, forest products, ro-ro, project and heavy-lift cargo.

Among other highlights, the tour will feature Genoa and Pra's container facilities – handling annually a total of over 2.6 million TEUs - including Genoa's flagship terminal VTE, operated by the PSA International Group, and equipped to accommodate the latest generation of ultra-large container vessels.

Tour guests will also have opportunity to view Genoa's shipyards equipped to offer repair, conversion and construction services for all classes of vessels from luxury yachts to bulk carriers - which together form one of the leading facilities in the Mediterranean.

After the boat tour in Genova, participants will be transferred by bus to Savona to visit the TERMINAL AUTO.
