Ferrovie dello Stato Italiane S.p.A., with reference to the application for registration in FS Italiane Group's Register of Lawyers and Legal and Tax Advisors (hereinafter referred to as "Register"), invites you to carefully read the information concerning the protection of personal data.

I. Data Controller and DPO This section provides details about our Data Controller and DPO

II. Types of personal data This section outlines the types of data we ask you for

The personal data processed are those voluntarily provided by the Data Subject and contained in the application form, which may therefore also include special data. In compliance with the principle of data minimisation, Ferrovie dello Stato Italiane S.p.A. will only and exclusively process those data strictly necessary for assessing the Registration request. The aforementioned data will be processed by computer and on paper in such a way as to comply with appropriate security and confidentiality measures.

III. Purposes of the processing This section indicates the purpose of the processing carried out on your data

Your personal data shall be processed for the purpose of assessing the Registration request, particularly in reference to the specialisation field, the geographical area in which you operate, and the operational needs of the Group Companies in relation to the previous elements (Mandatory provision of personal data. Legal basis: Legitimate interest).









IV. Data recipients

This section describes who will process your data and to whom the data will be disclosed

For the pursuit of the aforementioned purposes, the personal data provided shall only be processed by personnel expressly authorised by Ferrovie dello Stato Italiane S.p.A., who may need to do so in relation to their tasks or the hierarchical position they hold. These persons will be appropriately instructed in order to avoid loss, access to the data by unauthorised persons or unauthorised processing of the data. V. Data storage

In this section, we indicate how long we will retain your data

The Data Subjects' personal data shall be retained for up to 24 months after receipt of the request to be included in the Register. For professionals actually included in the Register, personal data shall be retained for as long as they are present in the Register.

VI. Rights of Data Subjects

In this section we indicate the rights you are entitled to

EU Regulation 2016/679 (Articles 15 to 23) grants data subjects the exercise of specific rights. In particular, in relation to the processing of your personal data, you have the right to request from Ferrovie dello Stato Italiane S.p.A.:

- Access: you may request confirmation as to whether or not data relating to
 you is being processed, as well as further clarification of the information set
 out in this notice;
 Rectification: you may request the rectification or
 supplementation of the data you have provided, if it is inaccurate or
 incomplete;
- Erasure: you may request that your data be deleted if it is no longer necessary for the purposes set out in section III, if you withdraw your consent or object to processing, if processing is unlawful, or if there is a legal obligation to delete it;
- Restriction: you may ask that your data be processed only for the purpose
 of storage, and that other processing be excluded, for the period necessary
 to rectify your data, in the event of unlawful processing for which you object
 to deletion, or if you need to exercise your rights in court and the data
 stored may be useful, or, finally, if you object to processing and a check is



- being carried out as to whether the Company's legitimate grounds prevail over yours.
- You may object at any time to the processing of your data, unless there are legitimate reasons for processing that override the Data Controller, e.g. for exercising the rights of and defending the company in court.
- Portability: you may ask to receive your data, or to have it transmitted to another data controller indicated by you, in a structured, commonly used and machine-readable format.

You may request Ferrovie dello Stato Italiane S.p.A. to exercise your rights at any time, by writing to titolaretrattamento@fsitaliane.it or by writing to the Data Protection Officer at protezionedati@fsitaliane.it. Furthermore, we inform you that you have the right, if you believe that your rights have been infringed, to lodge a complaint with the Supervisory Authority, which in Italy is the *Garante per la Protezione dei Dati Personali*.
